We live in a beautiful area of the Shenandoah Valley where we can take advantage of recreational activities year-round. Just a few minutes away from hiking, fishing, kayaking, and hunting.

We thought we'd take a moment and let you know that the Blue Ridge Shadows neighborhood is surrounded by a 50-year-old family hunt club that is active during the hunting season (October through January) on a secured range and over 800 acres of privately owned property. Each of the hunt club members are responsible and the youngest member of the club has been a member for over 20 years.

Some of the Blue Ridge Shadows lots are adjacent to gullies and we are all within a valley. These geographical features amplify the sound of these hunt club's activities. However, all activity occurs on private property in accordance with local, state, and federal laws.

ARCHITECTURAL REVIEW COMMITTEE

The ARC is responsible for maintaining and preserving the HOA's value by following the covenants, bylaws, and resolutions. The ARC consists of five BRS homeowners who volunteer their time to review applications for changes to structures or landscaping. The BRS Board has requested the ARC review and revise the current <u>Architectural Design and Maintenance Standards</u>. Our goal in this endeavor is to review all covenants, bylaws, and resolutions to develop a concise and accurate guideline that is easy for homeowners to use and interpret. We aim to put a revision of this document forward to the BRS Board in late 2020 or early 2021. Until that time, continue to use the *Architectural Change Request Form* found on the Coventry Group website.

The ARC reviewed 7 applications in September and 2 applications in October. The committee has been quick to take action on all applications received, with the response time ranging from 5 days to 2 weeks. As a reminder, the ARC has **45 days** from the receipt of the application by Registered Mail or Certified Mail to review and decide on applications. In the case that the homeowner needs an expeditious decision on their application, please inform Lisa Nokes at Inokes@coventrygrp.com.

Coventry Group is required to conduct monthly property inspections, which typically occur during the last two weeks of each month. If a homeowner receives a letter about a violation, they are encouraged to contact Lisa Nokes at Coventry Group to discuss the matter. Often times, violations may not be able to be resolved by the homeowner in a timely manner, but the management company is willing to work with the homeowner until they can achieve compliance.

Over the last few months, the main violations have been storage and neglect of trash cans and recycle bins. **DECLARATION**, **ARTICLE VI, RESTRICTIVE COVENANTS, SECTION 9** states, 'trash shall be collected and stored in trash receptacles only and not solely in plastic bags. Trash and garbage receptacles shall not be permitted to remain in public view except on days of trash collection, except those receptacles designed for trash accumulation located in the common area. No accumulation or storage of litter, new or used building materials, or trash of any kind shall be permitted on the exterior of any dwelling unit."

Per Design Standards: TRASH/RECYCLING CONTAINERS – Trash cans and recycling containers must be stored out of view of the street or adjoining properties at all times, except on scheduled pickup days. Containers should be placed out at curbside very early in the morning on pick up days or after dark the evening before. Storage in front or alongside of garages or the home is inappropriate. Screened areas for trash and recycling container storage may be incorporated into a deck design.

Other violations over this period include: lawn mowing, maintaining shrubs and flower beds, vehicles being stored in places other than the driveway or garage, and exterior maintenance of the home (power washing, faded doors and shutters).

Correction from the last newsletter, the DOG LEASH LAW is currently not in effect but Warren County Animal Control is working with the County Board of Supervisors to establish a COUNTY WIDE dog leash law that will include the Blue Ridge Shadows Community. Meanwhile, please keep your dog on a leash, for the safety of your dog, residents, children, and other dogs nearby.

TAKING OUT THE TRASH & RECYCLING

There have been many questions regarding the time trash and recycling will be picked up and what we can consider when recycling. Of course, it is always helpful to have a reminder of our HOA code as stated on page two.

Our current trash and recycling pickup provider is <u>American Disposal Services</u> (ADS). If you have specific questions or concerns about their service, please contact Lisa Nokes, Coventry Group Community Management, Inc., <u>Inokes@coventrygrp.com</u>. Ms. Nokes will contact the provider directly for a replacement tote, problem with service, or to order a recycling tote (\$75.00). Both totes are the property of ADS and are to remain at the residence.

TIMING, HOLIDAYS & INCLEMENT WEATHER

The Recycle!

Wednesday mornings beginning at 6:00 a.m., is our current pickup time, however, there is no set time. This is important to note so that residents can secure their trash taking natural elements like high wind, bears and raccoons into consideration, place your items curbside Tuesday evening.



Single Stream Recycling is a type of recycling that allows residents to place all types of recycled items together in their recycle tote and those items will be sorted later. ADS uses single stream recycling and encourages residents to not use a plastic bag when collecting these items for pick up. Use an acceptable BLUE or GREEN recycle totes. Most large retailers participate in plastic bag recycling programs.

OFF TO THE LANDFILL

If you want to know more about recycling, check out "Waste Wizard" on the ADS website, residents can search items to dispose and Waste Wizard directs residents on how and where to dispose of those items.

For example, Waste Wizard disposal of "glass" indicates that it is to be placed in the black tote and not the recycle tote. Please note that glass can be recycled through Warren County's Convenience Sites. More information on recycling and refuse disposal noted below.

WARREN COUNTY REFUSE COLLECTION, DISPOSAL AND RECYLE

The Warren County Solid Waste Department can also serve residents trash and recycling needs through Citizen Convenience Sites. Residents must have a Warren County, Town of Front Royal, or Waste Decal (permanently affixed to vehicles). The closest one is located at 10037 Winchester Road, Front Royal, VA 22630. Hours are 7 a.m. – 7 p.m. Thursday through Tuesday, closed on Wednesdays, Thanksgiving and Christmas Day.

- Scrap Metal (no freon appliances)
- Compact Fluorescent Bulbs
- Aluminum and Metal Cans
- Glass- All Colors
- Cardboard
- Batteries
- Waste Oil Gallon Containers or Less Only
- Plastics #1, #2, #3, #4, #5, #6 and #7 (no foam and no plastic bags)
- Paper, Mixed Paper, and Newspapers
- Paint


Enjoy holiday carols throughout Old Town Winchester provided by local choral groups.

WARREN COUNTY § 123-3 SPECIFIC ACTS OF NOISE DISTURBANCES:

BRS loves our furry friends. However, there is a noise ordinance that pet owners should adhere to regarding pets. As we live in a valley, the sound of dogs barking or howling carries throughout the neighborhood.

Please be considerate of your neighbors regarding the continuous noise (howling, barking, whining, meowing, squawking or other such noises) which are plainly audible across a property boundary or through partitions common to two residences within a building and that take place continuously or repeatedly during a period of at least 15 minutes in duration between 7:00 a.m. and 10:00 p.m. or during a period of at least 10 minutes in duration between 10:00 p.m. and 7:00 a.m. THANK YOU.
